Opportunity4Kids provides resources to Arizona children in need, that fall within 1.5% of the Federal Poverty Guidelines, to participate in out-of-school time activities, such as after school programs, summer camp and extracurriculars. These activities are shown to improve the Scholarship youth's self esteem, attitude and performance in school. Assistance is accomplished by supplying financial scholarships, equipment and uniforms - whatever the child needs to participate.

In 2018, Opportunity4Kids granted Scholarships to 93 unique youth and executed community programs that impacted 528 children.
